

### **From the General Manager**


The Environmental Protection Agency has three key major indicators to determine if a water system is operating well. They are: Technical, Financial, and Managerial. The idea is that if a water system is doing well in all three areas, the water system is providing safe water and is in compliance with the Safe Drinking Water Act. I am proud to say that the District is doing well in all three areas! Our staff is top notch and each member of the District team knows their responsibilities extremely well and we work well together. In FY2017, the District continued to make great strides forward. The financial position of the District remains solid. Many needed projects have been completed and more started.

Outside of the District, District staff continues to have key relationships with the Nevada State Engineer, Department of Environmental Protection, County Commissioner, City of Mesquite staff, Bureau of Land Management, and others.

The Drought/Water Availability discussion has quieted down as a result of above normal winter precipitation and outreach initiatives. Aquifer levels remain strong. Precipitation gauges surrounding the valley show no declines in annual precipitation. Residents and businesses continue to do a great job of water conservation.

Staff has been busy working on improvements to the District's infrastructure, key operational documents, and planning documents (master plan, capital projects, maintenance, and financial plans) to carry the District forward into the future.


FY2017 proved to be an eventful year as many projects were started with the aid of the new rates structure implemented in FY2015. The following projects were accomplished/started:






## **Financial Report**

The District is in an excellent financial position as a result of the rate increase instituted in FY2015 and recent debt refinancing.

In FY2017, the District implemented a software tool that allows for more accuracy in forecasting needed revenue adjustments. Staff is now able to quickly calculate, based on changes in expenses, what revenue streams are required to meet the growth and maintenance requirements. Our budget is very thoroughly vetted by the staff and by the board.
